The first cases were revealed in Polrestabes Surabaya, dated September 9, 2014, investigators arrested a young man named Dewi Sundari SPG and SPG 12 men can wear that into prostitution with the cheapest rates Rp. 1,000,000.00 -Rp. 2,000,000.00. The second case, on February 20, 2016 investigators have arrested a young SPG initials S-W who run prostitution terselebung business by offering 12 people SPG to a smooth operator. An SPG initials S-W is wearing a high rate of about Rp 1.500.000,00 for each SPG working as commercial sex workers. Investigators difficult to establish the suspect and the victim in the disclosure of prostitution and people trafficking among SPG. Sehhingga, made late in the investigator handling the case and contrary to the rules Police Regulation No. 14, 2012. The problems that I researched on is action taken by the investigator at Surabaya Polrestabes against prostitution and trafficking People in the SPG; Constraints and efforts Investigators in Polrestabes Surabaya handling Against Prostitution and trafficking Covert SPG Insider circles; and Related Legal Certainty Covert Prostitution and Trafficking Among SPG In Regulation Legislation in Indonesia.

In this study the authors use a kind of empirical legal research. The author uses juridical sociological approach. Methods of sociological juridical approach is the approach of concerns regarding the issues examined in terms of the science of law in the form of legislation in Indonesia and connecting some facts about crime Prostitution and trafficking are revealed by investigators Polrestabes Surabaya to go straight interview persons who used to answer the problem of thesis research the authors write.

The results of the research to answer three questions raised by the author of Action Taken by the Investigator in Polrestabes Surabaya Against Prostitution Covert and Insider Trading Members of the SPG is to receive the report, investigation, investigation by means of a search agency, seizure, and examination of suspects and witnesses, the detention. Constraints are divided into three namely constraint structure (lack of members of the investigator, the investigator was slow in making the results of the investigation report 2x 24 hours), substance (the investigator is difficult to determine a suspect for the cast PSK because of the absence of rule of law in the Criminal Code of commercial sex workers), and the culture which includes the low economic communities with the potential offense that pidana. Upaya preventive legal counseling, providing information through social media, checking, cooperation with people who are aware of the technology and repressive measure that improve the local economy in Surabaya; Extra members Polrestabes investigator at Surabaya; PSK as a witness in the trial and required the renewal of the Criminal Code to regulate the legal bondage for commercial sex workers who engages in prostitution.
