1. Bagi Perawat  
Perawat perlu meningkatkan pengetahuan tentang pertolongan pertama pada kecelakaan kepada orang awam khususnya di daerah yang rawan kecelakaan sehingga ketika korban dibawa ke rumah sakit diharapkan sudah mendapatkan mendapat pertolongan pertama pada kecelakaan yang sesuai.
2. Bagi Peneliti Selanjutnya  
Penelitian selanjutnya perlu dilakukan analisis univariat dan dilakukan dengan sampel yang lebih banyak dan mekanisme cedera yang lebih spesifik (korban tabrakan, kecelakaan tunggal, *driver / passanger*, menggunakan mobil/motor/ kendaraan non mesin, jatuh dari tangga atau jatuh dari ketinggian secara langsung), ada tidaknya pemberian pertolongan pertama pada kecelakaan, proses transportasi dan stabilisasi korban.
