Sartre nevertheless insists that his existentialism is a formsital humanism, and he strongly emphasizes human freedom, choice, and responsibility. He eventually tries to reconcile these existentialist concepts with a Universi Marxist analysis of society and history. Sartre's primary idea is that people, as humans, are "condemned to be Universi free". This theory relies upon his position that there is no creator, and is illustrated sitas using the example of the paper cutter. Sartre says that if one considered a paper Universit cutter, one would assume that the creator would have had a plan for it: an essence. Sartre says "human beings have no essence before their existence because there is no Creator." It is the very definition of "existence precedes essence". This forms Universi the basis for his assertion that since one cannot explain their own actions and tas Brawij behaviour by referencing any specific human nature, they are necessarily fully_{sitas} responsible for those actions.
