SUMMARY

DINAR AYU ANANDA, Public Administration Law, Faculty of Law, University of Brawijaya, January of 2014, THE DUTY OF REGIONAL GUARDIAN POLICE UNIT IN THE RESTRUCTURING OF STREET VENDORS (The Study of The Implementation of Article 3 Section 1 Local Regulation of Kediri City Number 43 of 2008 about the Overview, Duty and Function of The Work Order of Regional Guardian Police). The objective of final paper is to understand the implementation of Article 3 Section 1 Local Regulation No. 43 of 2008 about The Restructuring of Street Vendors at Kediri City and to acknowledge the constraints and the solutions faced by the regional guardian police in the restructuring of street vendors at Kediri City. The background of this selected theme by many public opinions is that the implementation of regional guardian police's duty in the restructuring of city street vendors is responded by negative opinion either from the community or from street vendors themselves.

Problems are determined such as (1) How is the implementation of Article 3 Section 1 about Local Regulation of Kediri City No. 43 of 2008 about The Overview, Duty and Function of Work Order of Regional Guardian Police Unit in the Restructuring of Street Vendors at Kediri City; and (2) What are constraints faced by Regional Guardian Police in the restructuring of street vendors at Kediri City and what are solutions suggested by Regional Guardian Police to deal with constraints during the restructuring of street vendors at Kediri City.

Type of research is empirical law research. Problems are discussed and elaborated based on the regulations by connecting the fact of community. Data are analyzed descriptively. This descriptive method is a procedure of problem solving to analyze, to expose or to describe data from the result of field observation. Literature study is analyzed and interpreted by giving a conclusion remark.

Result of research indicates that Regional Guardian Police Unit in the restructuring of street vendors at Kediri City based on Article 3 Section 1 of Local Regulation of Kediri City No. 43 of 2008 has been consistent with the Duty and Function. Indeed, Regional Guardian Police has been selective in restructuring street vendors based on the function and authority. The implementation of Article 3 Verse 1 of Local Regulation of Kediri City No. 43 of 2008 about The Position, Duty and Function of Regional Guardian Police Unit in the restructuring of street vendors at Kediri City is based on the factors influencing the prevail of law which are law structure, law substance, and law culture. Regional Guardian Police Unit has restructured street vendors in the field by emphasizing four models of policy implementation, such as Communication, Human Resource, Disposition, or Attitude and Structure of Bureaucracy. The constraints challenged by Regional Guardian Police Unit in the restructuring of street vendors at Kediri City are the limited human resource and infrastructure, the factor of community and the culture.
