INTRODUCTION

1.1 Background

Indonesia is the biggest archipelago country in the world, consists of 17.500 big and small islands that spread around the equator, which is line along the Sabang to Merauke. Indonesia is also called as a maritime country. The territorial includes the land and the water area. It is a country which 70% of the water area, so the sea is the main physic environment.

Though Indonesia has a very vast territorial, even the vastest country in Southeast Asia, but Indonesia still become a growing country so Indonesia still need a lot of development. Development of Indonesiais needed. The development must scope all of the society aspects. The society prosperity become the miles stone of the success in the development for all of the countries, include Indonesia.

Based on Affifudin (2012:78) the national development as a continuity process in order to increase the citizen prosperity in a planned way and directed in every aspect of the citizen life and living, the nation and Republic of Indonesia for reaching the dreams and the national goal just like been set in the introduction of the Basic Law of 1945.

The fishery potentials in Tulungagung which is a part of the south beach of east java, include the Under Exploited with the wide for about 755,4 miles and the sea length is for about 122 miles with the fish resources for about 25.000 ton/year, the degree of the utilization is only for about 29-32%. The basic factor in developing the fishery business is by supplying the sufficient facility for fisher and having a capacity for serving the fisherman.

Tulungagung has one fish anchorage called as the PPI Popoh. The anchorage become the center of the fish auction in Popoh and surrounds it. The location which is easy to reach makes Popoh become the fishery center in Tulungagung. The anchorage has the main role in supporting the increasing of the fishery product. Smoothen the fishery traffic, supporting the development of the fishery society economy. The implementation and the controlling of the fish resources and fasten the service to all the activities in fishery sector business, especially for fisher.

PPI becomes a new alternative for developing the Popoh beach area. The Popoh area for long ago is a develop tourism area, most of the people there become traders and fishermen. But the glory of the Popoh beach as the tourism area is decreasing time by time, and make the people become jobless even looking for another job.

PPI which is established on 2004 gives a lot of benefit, PPI become the center of the auction around the south coast. All of the fishermen were doing the auction in the PPI Popoh. PPI has a great role in the local area economy.

The roles society very important, the making of PPI is for the society. The society has a great contribution in developing the PPI Popoh. The tourism area is changing into a tourism area which based on the fishery.

The society doing activity in PPI Popoh mostly are the local people. They use the facility which is made by the government for fulfilling their daily need. The activities such as trading and sealing.

The fisherman sealing consist of the labor fisherman and the master of the ship. The master of the ship is the owner of the ship who supplying all the need for the sealing. And the labor fisherman is a sealing fisherman who does not has a ship for sealing and helping the fisher process. The system which is used for sharing the result is the appropriate sharing of the sealing. Sometimes the fisherman used the fish for making the salty fish which can be kept for a long time for be an alert when the famine season comes.

Popoh beach has two seasons, the fish season is in the dry season and when the wet season come, will be hard to find fish there. Because the location of Popoh beach is a flowing beach so the Popoh is the road for the fish transmigration. That is why Popoh has two season. The flowing is so fast, so it is not a good place for the fish.

The society as the fish trader or the food trade, has a shop near the auction location which is supplied by the local government. By paying the rent cost which is paid every year, the electricity and water which is paid to PPI Popoh every month. So they can use the facilities which been supplied by the PPI Popoh.

The facility which is supplied by the PPI Popoh is quite giving the easiness and many advantages for the local people. The people who become a seller in the last few year in the Popoh beach move to the PPI area, because the visitor in the Popoh beach are decreasing year by year.

The society and the government have an important role in developing the Popoh beach area. PPI become facilitation for developing the area. The policy which is made by the government gave a great effect to the local people. The advancement of this area need a cooperation between the society and the government. The roles of the government and the society have a relation which giving influence to each other.

The government role in the development of the area is in the regulation, the government regulate all, from the ship license, retribution, the regulation about the fuel and also about the fish which is protected. Facilitation that is supplied by the DKP is quite complete, such as the fish market, the ice factory as the PPI complement, the multipurpose building, and the other facilitation. But there are still too many insufficient infrastructure, such as the route to the PPI is still difficult to pass. The road along the Campurdarat until PPI is still bumpy, even really bad. When the rain fall the road is slicking by the water and mud in the Gamping until Gambiran. The duty of the government as the infrastructure supplier is still lack. But with a new alternative with making PPI Popoh, now PPI Popoh become populer in society, there is coorporation between society and government in developing PPI Popoh. Because of that the researcher interests to conduct the research in title of
