CHAPTER V

CONCLUSION AND SUGGESTION

5.1 Conclusion

The government built this fish landing facilities in addition to developing the potential of Popoh, government also give serve, facilities, and welfare of the community. The government provides facilities to increase people's income. The availability of such facilities is capable of providing ease of the local communities.

1. In the development of PPI Popoh, there is good cooperation between the government and the community. The government doing its part as well as the availability of facilities and regulations. The government is cooperating with the local communities as fishermen and traders. Regulation and facility provided the government may increase the welfare of local communities. The communities can perform its function well. They sort of feeds program that made and provide feedback to the government. The government can fulfill its function as regulator, stability, facilitator, mediator, and dynamist, while the communities were able to maintain their rights protected, influencing the policy made by the government, overseeing SDM that can develop or communicating between societies. 5.2 Suggestion

With the study and analysis on the partnership between the government and the communities in the development of PPI Popoh, so the researcher can provide suggestions. Suggestions that the researcher give is, expected to be a consideration in determining policies. Here are some suggestions;

- PPI Popoh needs more employees to back up the head of PPI Popoh. The lack of employees make many jobs are delayed or unsolved.
- 2. The lack of infrastructural including fleets, development of building, completeness in fishing process, and policy boundary fishing. The addition of a larger ship assistance, so the fishermen can fishing to the sea and earn more. It is because most of the fishermen have small boats so that fishermen could not stay in the sea. And the result was less then the expenditure, if using a large ship, they can facilitate to stay at sea.
- 3. The facilities in PPI Popoh were good, yet there are still lacking. Provision of landfills for trash is still not ready, so that it was accumulated in the mountain. This can cause the damage to the environment. Car hauler of trash also does not exist.
